3. Full details of dates for the AGM and any Special Meetings are published in the Trade Press as well as on our web site (www.newstraid.org.uk), along with copies of the Annual Report and Accounts of the Fund.
4. Full Voting Membership is either £20 per annum for a calendar year, renewable by 31st March of the following year, £60 for three calendar years or a £200 one-off payment for full Life Membership.
